Ensure the health and safety of your team and your work environment

Last year in Georgia, more than 500 manufacturers were inspected by OSHA. Did you know that workplace injuries and illnesses cost the U.S. \$250 billion annually? Are you concerned about being at risk for health and safety violations? Have you had any lost-time work incidents?

Meeting the OHSAS (Occupational Health and Safety Assessment Series) 18001 standard requirements allows organizations to minimize safety risks. OHSAS 18001 is a system-based approach that applies to all employees, contractors, and visitors.

➤ GaMEP will:

- Draft or evaluate an Occupational Health & Safety (OH&S) policy to meet the requirements of the standard.
- Determine how change management can support improvements in safety and health.
- Define tools for participation and consultation.
- Identify opportunities for process and operational controls integration.
- Distinguish existing OH&S performance metrics that meet OHSAS 18001 requirements.

By working with GaMEP to implement OHSAS 18001 and integrate the standard into their existing management system, Yamaha:

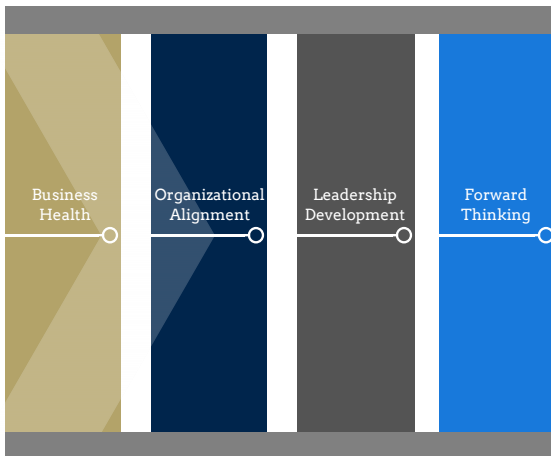
- Added 5 new employee safety committees.
- Increased by more than 50% the number of implemented improvement projects that included a safety component.
- Reduced safety hazards, increased production capacity, and improved labor utilization, resulting in 292 seconds of time savings per cycle, a 61% risk reduction, and a total cost savings of \$87,000 per year.
